ASSIGNMENT OF U.S. TRADEMARKS

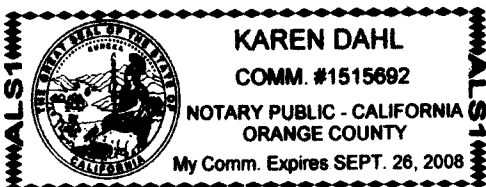
