**Assignment and Bill of Sale**

Pursuant to, and in connection with, that certain Plan of Complete Liquidation and Dissolution (the "Plan") as executed by CASINO DATA SYSTEMS, a Nevada corporation, with a business address of 7230 Amigo Street, Las Vegas, Nevada 89119 (the "Liquidating Entity"), the Liquidating Entity does hereby assign, sell, transfer, and convey to ARISTOCRAT TECHNOLOGIES, INC., its parent company, with a business address of 7230 Amigo Street, Las Vegas, Nevada 89119, (the "Parent Company"), all of the Liquidating Entity's property and assets, currently known or hereinafter discovered (the "Assets").

TO HAVE AND TO HOLD, the Assets hereby conveyed, all and singular, unto the Parent Company, to and for its use and benefit.

Liquidating Company represents and warrants to the Parent Company that it has good and valid title to and is the lawful owner of the Assets, and that Liquidating Company has the right to convey the Assets free and clear of all liens, claims and encumbrances.

Liquidating Company, its officers and directors, at any time and from time to time after the date hereof, upon the reasonable request of the Parent Company, shall do, execute, acknowledge and deliver, or will cause to be done, executed, acknowledged or delivered, all such further acts, deeds, assignments, transfers, conveyances, powers of attorney or assurances as may be required for the better transferring, assigning, conveying and confirming to the Parent Company, or for aiding and assisting in reducing to possession by the Parent Company, any of the Assets or rights being purchased hereunder, or to vest in the Parent Company good, valid and marketable title to such Assets and rights.


Further, upon receipt of all applicable gaming regulatory approval, which approval was obtained as of September 2, 2005, each share of the Liquidating Company, whether certificated or uncertificated, shall no longer be outstanding and shall automatically be canceled and retired and shall cease to exist and the stockholders of the Liquidating Company shall cease to have any rights with respect thereto.

This Assignment and Bill of Sale shall inure to the benefit of the Parent company and shall be binding upon Liquidating Company, its successors and assigns.


