RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is given on this ____ day of June 2006 by CIT Lending Services Corporation (formerly known as Newcourt Commercial Finance Corporation), as Agent ("CIT"), a Delaware corporation, to PaeTec Communications, Inc. (in its own capacity and as successor in interest by merger with Campuslink Communications Systems, Inc. and as successor in interest by merger with PaeTec Online, Inc.) (collectively "PaeTec"), a Delaware corporation, as follows:

WHEREAS, on May 12, 1999, Newcourt Commercial Finance Corporation, as Agent ("Newcourt") and PaeTec Communications, Inc. entered into a Trademark Security Agreement (the "May 1999 Trademark Security Agreement");

WHEREAS, pursuant to said May 1999 Trademark Security Agreement, PaeTec granted to Newcourt, among other collateral, a continuing security interest in all of PaeTec's right, title and interest, including goodwill, in, to and under the United States trademarks listed on the attached Schedule A (the "May 1999 Marks");

WHEREAS, said May 1999 Trademark Security Agreement was recorded in the United States Patent & Trademark Office on the following dates:

- A. June 30, 1999 at reel 1923 and frame 0253;
- B. June 30, 1999 at reel 1923 and frame 0276;
- C. December 01, 1999 at reel 1998 and frame 0120;
- D. May 12, 2004 at reel 2848 and frame 0145, relating to later filed or acquired marks as of August 4, 2000;
- E. May 12, 2004 at reel 2848 and frame 0193, relating to later filed or acquired marks as of March 31, 2004;
- F. May 12, 2004 at reel 2848 and frame 0178, relating to later filed or acquired marks as of August 4, 2000;
- G. May 13, 2004 at reel 2848 and frame 0537, relating to later filed or acquired marks as of March 31, 2004; and
- H. March 16, 2006 at reel 3270 and frame 0472.

WHEREAS, Newcourt subsequently changed its name to CIT Lending Services Corporation on April 17, 2000;

WHEREAS, on September 9, 1999, Newcourt Commercial Finance Corporation, as Agent ("Newcourt") and Campuslink Communications Systems, Inc. ("Campuslink") entered into a Trademark Security Agreement (the "September 1999 Trademark Security Agreement", and together with the May 1999 Trademark Security Agreement, the "Trademark Security Agreements");

WHEREAS, pursuant to said September 1999 Trademark Security Agreement, Campuslink granted to Newcourt, among other collateral, a continuing security interest in all of Campuslink's right,

title and interest, including goodwill, in, to and under the United States trademarks listed on the attached Schedule A (the "September Marks", and together with the May 1999 Marks, the "Marks");

WHEREAS, said September 1999 Trademark Security Agreement was recorded in the United States Patent & Trademark Office on November 5, 1999 at reel 1991 and frame 0829;

WHEREAS, Campuslink subsequently merged into PaeTec Communications, Inc. on January 12, 2000; and

WHEREAS, CIT now wishes to release its security interests in the Marks and retransfer and reassign to PaeTec without recourse all of CIT's right, title and interest in and to the Marks.

NOW THEREFORE, as PaeTec has satisfied its obligations under said Trademark Security Agreements, CIT hereby releases any security interest it may have in the Marks, and reassigns any and all right, title and interest it may have in and to the Marks without recourse to PaeTec.
