ASSIGNMENT OF TRADEMARKS-U.S.



ASSIGNOR covenants and agrees that, when requested, ASSIGNOR shall, without charge to ASSIGNEE by at ASSIGNEE'S expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable, or convenient in connection with said Marks, and for the defense and protection thereof if challenged in a court of law.

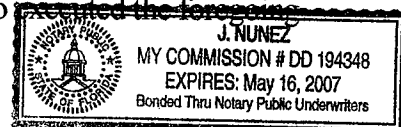
