TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement") is made this 31st day of March, 2006 between London Fog Group, Inc., formerly known as London Fog Industries, Inc., a Delaware corporation, with its principal place of business at 1700 Westlake Avenue North, Suite 200, Seattle, Washington 98109 ("Assignor") and Pacific Trail Corporation, an Oregon corporation, with its principal place of business at 14375 NW Science Park Drive, Portland, Oregon 97229 ("Assignee"), pursuant to that certain Asset Purchase Agreement dated as of March 31, 2006 among Assignor, Assignor's wholly owned subsidiary, Pacific Trail, Inc., and Assignee's parent company, Columbia Sportswear Company (the "Purchase Agreement").

Assignor is the owner of the applications and registrations of the marks shown in the attached Schedules A and B (the "Trademarks");

Pursuant to the Purchase Agreement Assignor has sold to Assignee all of Assignor's right, title and interest in and to the Trademarks and the goodwill associated therewith; and

Assignee wishes to acquire all of Assignor's right, title and interest in and to the Trademarks and the goodwill associated therewith.

Unless otherwise defined, terms that appear in this Agreement with their initial letters capitalized and are not otherwise defined shall have the meanings ascribed to them in the Purchase Agreement (including all schedules and exhibits), and the terms of the Purchase Agreement (including all schedules and exhibits) are incorporated by this reference in this Agreement.

NOW, THEREFORE, for the consideration delivered at the Closing, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers, and conveys unto Assignee all of its rights, title and interest in and to the Trademarks, whether statutory or at common law, including all applications and registrations thereof, together with the goodwill of the business symbolized by the Trademarks, and the right to sue for, collect and retain all damages and profits and all other remedies for past infringements thereof.

This Agreement is being executed and delivered pursuant to the Purchase Agreement and shall be construed in a manner consistent with the terms of the Purchase Agreement. Except for the Purchase Agreement, this Agreement contains the final, complete and exclusive understanding between Assignor and Assignee regarding its subject matter and supersedes any prior or contemporaneous agreement, understanding, or representation, oral or written, by either of them. The validity, construction, interpretation, and enforcement of this Agreement shall be governed by the laws of the State of Delaware. In the event of any litigation, arbitration or other proceeding arising out of the subject matter of this Agreement, the nonprevailing party shall pay the prevailing party's costs and expenses (including attorneys' fees) incurred in such proceeding or any appeal, including any bankruptcy proceeding.



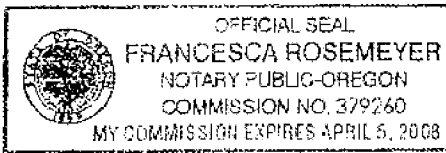
