TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is made between the Miami Tribe of Oklahoma Business Development Authority, a subordinate economic enterprise and political subdivision authorized and incorporated under the Miami Tribal Business Act of 1999 by the Miami Tribe of Oklahoma, a federally recognized Indian tribe organized under Section 3 of the Act of June 26, 1936 (48 stat. 1967) (hereinafter "Assignor") and eLink, L.L.C., a Oklahoma Limited Liability Company (hereinafter "Assignee").

WHEREAS Assignor is the owner of the marks identified in Schedule A hereto ("Mark(s)");

WHEREAS Assignor has used the Marks to identify Assignor as the source of the goods and services provided thereby; and

WHEREAS Assignor has sold, assigned and/or otherwise transferred over such portion of the business associated with the Marks to Assignee; and

WHEREAS Assignee is desirous of acquiring the entire right, title and interest in and to the Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignor does hereby sell, transfer, assign and otherwise convey to Assignee, its successors and assigns, all Assignor's right, title and interest throughout the world, in the following:


- (i) each Mark and any registration and renewals for each Mark, including, but not limited to, the registrations for such Marks identified in Schedule A;
- (ii) the goodwill of that portion of Assignor's business connected with, pertaining to, and symbolized by each Mark; and
- (iii) the ownership of all causes of action for, and claims for damages by reason of infringement of each Mark, which actions arose prior to the date of execution hereof.

2. This Trademark Assignment shall inure to the benefit of, and shall be binding upon, the successors and assigns of the parties.

3. Assignor hereby agrees that Assignee shall have the right to record this instrument of assignment.
