ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks (the "**Assignment**") is made as of the 26th day of May, 2006, by and between MCD Incorporated, a Wisconsin Corporation, 2547 Progress Road, Madison, Wisconsin 53717 ("**Assignee**") and Fiskars Brands, Inc., a Wisconsin Corporation, 2537 Daniels Street, Madison, Wisconsin 53718 ("**Assignor**").

WITNESSETH:

WHEREAS, Assignor and Assignee have entered into an Asset Purchase Agreement (the "**Agreement**") under the terms of which Assignee has acquired certain business assets of Assignor including but not limited to the trademarks described in Exhibit "A," attached hereto and incorporated herein by reference (the "**Trademarks**"); and

WHEREAS, this Assignment is executed by the parties for the purpose of transferring all right, title and interest of Assignor in and to the Trademarks to Assignee.

NOW, THEREFORE, in consideration of the foregoing recitals, the Agreement between the parties and other good and valuable consideration, it is agreed by and between the parties hereto as follows:

1) **Identification of Trademarks.** The Trademarks assigned by this Assignment are described in Exhibit "A," attached hereto and incorporated herein by reference.

2) **Assignment.** Assignor does hereby assign to Assignee, all right, title and interest of Assignor, in and to the Trademarks described in Exhibit "A," and any and all goodwill symbolized by said Trademarks, as well as all right, title and interest of Assignor in and to all certificates of registration, applications for registration and similar property interests relating to the Trademark. Assignee hereby accepts such assignment. This Assignment shall include an assignment of the Assignor's right to receive all income, royalties, damages and payments now or hereafter due or payable with respect to the Trademarks, and all causes of action (either in law or in equity) and the right to sue, counterclaim or recover from third parties for past, present and future infringement of the rights assigned under this Assignment.

3) **No Interest Retained.** Assignor retains no title, interest, license or other rights in and to the Trademarks assigned hereby. All warranties and representations of Assignor with respect to the Trademarks hereby assigned, shall be as set forth in that certain Asset Purchase Agreement between Assignee as buyer and Assignor as seller executed by the parties contemporaneously herewith.

4) **Notices.** Assignee shall file such notices or registrations with the United States Patent and Trademark Office as may be necessary to perfect this Assignment, and all costs thereof shall be borne by Assignee. To the extent deemed necessary or required by Assignee, Assignor agrees to execute any such documents as Assignee may reasonably require to be executed by Assignor in connection therewith.

5) **Delivery of Documentation.** Assignor represents that it will, within 10 business days of the execution of this Assignment, deliver to Assignee all documentation and certificates relating to said Trademarks which are in the possession and control of the Assignor.

6) **Miscellaneous.** This Assignment shall be governed by and construed in accordance with the laws of the State of Wisconsin. This Assignment constitutes the entire agreement between the parties, and may not be modified or amended except by a written document signed by the party against whom enforcement is sought. This Agreement shall be binding upon the parties hereto, and their respective successors and assigns.






