Assignment of Trademark Rights

WHEREAS, Ortho Development Corporation, a Utah corporation, with its principal place of business at 12187 South Business Park Drive, Draper, Utah 84020 ("Assignor"), owns and has a *bona fide* intent to use the trademark EMF PAL ("the Mark") in connection with the following goods: surgical instruments and apparatus for separating, severing, cutting, coagulating, vaporizing or devitalizing tissues for medical and surgical purposes in International Class 010; and

WHEREAS, Assignor has applied to register the Mark on the Principal Register of the United States Patent and Trademark Office based on Assignor's *bona fide* intent to use the mark in commerce in connection with the above-described goods, U.S. Application Serial No. 78/708,516 filed on September 7, 2005 (the "Application"); and

WHEREAS, Japan Medical Dynamic Marketing, Inc., a company organized and existing under the laws of Japan, with its principal place of business at 2-2 Ichigayadaimachi, Shinjuku-ku, Tokyo, Japan 162-0066 ("Assignee"), is desirous of acquiring from Assignor the entire right, title and interest in and to the Mark, together with the Application and the business and accompanying goodwill pertaining thereto, including that portion of Assignor's business and goodwill with which the Assignor has a *bona fide* intent to use the Mark and the Application, and Assignor is willing to assign the Mark, the Application and associated business and goodwill to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign and transfer to Assignee, the entire right, title, and interest in and to the Mark, including the Application and business and goodwill pertaining thereto, including that portion of Assignor's business and goodwill in connection with which Assignor has a *bona fide* intent to use the Mark, together with any claims, demands and causes of action for the past infringement of the Mark or for unfair competition in business in connection therewith, the same to be held and enjoyed by Assignee, its successors, assigns or other legal representatives as fully and entirely as the same would or could have been held and enjoyed by Assignor had this Assignment not been made.
