AND WHEREAS it is a term of the Share Purchase Agreement that DSM USA shall cause its affiliates owning the trademarks described in Exhibit "A" to assign such trademarks to Fiberfil;

AND WHEREAS, Fiberfil is an Ontario corporation, the full post office of whose principal office or place of business is 233 Arvin Avenue, Stoney Creek, Ontario, L8E 2L9;

NOW THEREFORE DSM IP hereby confirms that in consideration of the payment to it of US\$2.00 and other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, it has sold, assigned and transferred, and by these presents does sell, assign and transfer unto Fiberfil, its successors and assigns, the whole right, title and interest in and to the Trademarks together with the goodwill associated therewith.
