WHEREAS the Assignor is the proprietor and registered and/or beneficial owner of the Intellectual Property described on Schedule A hereto, including all common law, statutory, treaty and convention rights (including rights of priority) concerning such Intellectual Property, and the goodwill of the business associated therewith and symbolized thereby;

AND WHEREAS pursuant to an Asset Purchase and Assignment Agreement dated the date hereof (the "APA Agreement") between the Assignor and the Assignee, the Assignor agreed to sell, assign and transfer to the Assignee, and the Assignee agreed to purchase, all right, title and interest of the Assignor in and to all property and assets of the Assignor, other than the Excluded Assets, including the Intellectual Property;

AND WHEREAS capitalized terms that are used but not otherwise defined herein shall have the respective meanings given to such terms in the Asset Purchase and Assignment Agreement;

NOW THEREFORE in consideration of the transactions contemplated by the APA Agreement, the sum of \$10.00 received from the Assignee and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor declares as follows:

1. Assignment to Assignee

The Assignor hereby assigns, transfers and conveys to the Assignee all of its rights, title and interest in and to the Intellectual Property described on Schedule A hereto, including all common law, statutory, treaty and convention rights (including rights of priority)

2. Applicable Law

This Assignment shall be construed, interpreted and enforced in accordance with, and the respective rights and obligations of the parties shall be governed by, the laws of the Province of Ontario and the federal laws of Canada applicable therein.

3. Further Assurances

From time to time subsequent to the date hereof, the Assignor covenants and agrees that it shall execute and deliver all such further documents and do such other things as the Assignee, acting reasonably, may request be executed or done in order to better evidence or perfect or effectuate the assignment contemplated hereby or to give full effect to this Assignment.

4. Successors and Assigns

This Assignment shall enure to the benefit of and shall be binding on and enforceable by the Assignor and the Assignee and their respective successors and assigns.
