NOW, THEREFORE, the receipt and adequacy of good and valuable consideration being hereby acknowledged, and upon the terms set forth in this Confirmation of Termination and Release:

1. Confirmation of Termination and Release. The Secured Party hereby confirms the termination and release of the Security Interests in the Trademarks as of May 31, 2006.

2. Trademarks. The term "Trademarks" as used herein, shall mean all of the Pledgor's right, title and interest of every kind and nature in the trademarks as set forth on Schedule A attached hereto.

3. Further Assurances. The Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to confirm release of the Security Interests contemplated hereby, and/or the recordation thereof.
