

Assignee or which, in the sole judgment of the Assignee, may be necessary to obtain, maintain, issue or enforce said Trademarks.

To the extent that this Trademark Assignment conflicts with the terms of the Asset Purchase Agreement, the terms of the Asset Purchase Agreement are controlling.

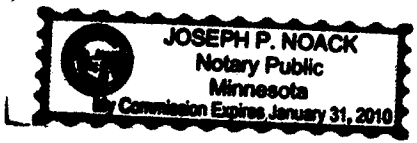
