**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

*Credit Suisse, Cayman Islands Branch  
(Formerly known as*

TERMINATION AND RELEASE dated as of December 28, 2005, from Credit Suisse First Boston, acting through its Cayman Islands Branch, as Administrative Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to Anvil International, Inc., a Delaware corporation with its principal place of business located at 500 W. Eldorado Street, Decatur, IL 62522 ("Grantor").

WITNESSETH:

WHEREAS, pursuant to the Second Amended and Restated Credit Agreement, dated as of April 23, 2004 (amending and restating the Amended and Restated Credit Agreement, dated as of June 24, 2002), made by the Borrower (as defined therein) in favor of the Agent (the "Collateral Agreement"), a security interest (the "Security Interest") was granted by the Borrower to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, in connection with the Collateral Agreement, the Grantor executed and delivered a Second Amended and Restated Subsidiary Pledge and Security Agreement, dated as of April 23, 2004 (the "Pledge and Security Agreement");

WHEREAS, pursuant to that certain Trademark Security Interest dated as of April 23, 2004, among the Agent and the Grantor (the "Security Agreement"), the Grantor, by reference to the Pledge and Security Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 28, 2005, at Reel 3112 and Frame 0428 and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement and the Pledge and Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

I. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Exhibit A hereto). The term "Trademarks" shall have the meaning provided by reference in the Collateral Agreement and the Pledge and Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
