**RELEASE AND REASSIGNMENT OF SECURITY INTERESTS IN PATENTS AND  
TRADEMARKS**

THIS RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS (this "Release") is dated as of April 12, 2006 by Deutsche Bank Trust Company Americas f/k/a Bankers Trust Company, in its capacity as Collateral Agent ("Agent") under that certain Security Agreement with Atrium Companies, Inc., as borrower, dated as of November 27, 1996 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement").

WHEREAS, Agent and Atrium Companies, Inc., a Delaware corporation, ("Borrower"), entered into that certain Security Agreement, dated as of November 27, 1996 (the "Agreement");

WHEREAS, the Agreement granted Agent a security interest in, among other things, certain United States and foreign patents, patent registrations, patent applications and other intellectual property rights, including, without limitation, the patents listed on Schedule A attached hereto (the "Released Patents") and certain United States and foreign trademarks, tradenames, trademark registrations, service marks, trade styles, terms, designs and trademark applications and other intellectual property rights, including, without limitation, the trademarks listed on Schedule A attached hereto (the "Released Trademarks"), as security for certain obligations of Borrower to Agent (the "Obligations");

WHEREAS, Agent recorded the Agreement on January 8, 1997 at Reel 8283, Frame 0918 and at Reel 1541, Frame 0971 in the United States Patent and Trademark Office ("PTO"); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

Agent hereby fully releases and terminates its security interest in and lien on, and grants a re-assignment to Borrower of the following:

(a) all of Borrower's now existing or hereafter acquired right, title and interest in and to all Released Patents which are now filed with the PTO, any similar office or agency of any state, territory or possession of the United States or Canada or any similar office or agency of any other country, or used in the United States, any state, territory or possession thereof including, without limitation, Puerto Rico, or any other country, and (i) any renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages, and payments for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, (iv) all documents, packages, prints and labels on which said Released Patents have appeared and all designs and general intangibles of a like nature, and (v) all rights corresponding thereto throughout the world; and

(b) any claims by Borrower against third parties for infringement of the Released Patents or of any license with respect thereto.
