Background

- A The Assignor owns the IP (as defined in this deed).
- B On the terms and conditions contained in this deed:
- (i) the Assignor has agreed to assign the IP to the Assignee; and
 - (ii) the Assignee has agreed to accept that assignment from the Assignor.

This deed witnesses

that in consideration of, among other things, the mutual promises contained in this deed, the parties agree:

Agreed terms

1. Defined terms & interpretation

1.1 Defined terms

In this document:

Business means the business carried on by the VFS Group as at 27 January 2006, including the business of manufacturing and marketing early warning fire detection and control systems and video-based surveillance systems and automated voice alarm and evacuation systems.

Confidential Information has the same meaning as in the Share Sale Agreement.

Designs means the design registration set out in Schedule 3.

Effective Date means 28 February 2006.

Intellectual Property Rights or **IPR** means all intellectual property and proprietary rights (whether registered or unregistered) including:

- (a) business names and domain names;
- (b) trade or service marks, including any trade mark or service mark applications;
- (c) any right to have information (including Confidential Information) kept confidential; and
- (d) patents, patent applications, drawings, discoveries, inventions, improvements, trade secrets, technical data, formulae, computer programs (in source code and object code), data bases, know-how, logos, designs, design rights, design applications, copyright, circuit layout rights and similar industrial or intellectual property rights.

Invetech Assignment Deed means the deed between Invetech Pty Ltd (ACN 004 301 839) and the Assignor dated 11 January 2006 (as amended) and novated from Vision Fire & Security Pty Limited to the Assignor on 27 February 2006 and novated from the Assignor to the Assignee on 28 February 2006.

IP means all IPR (including the Patents, Trade Marks and Designs) that are:

- (a) owned by the Assignor; and
- (b) used in the Business

including the IP assigned under the Invetech Assignment Deed.

Patents means the patents and patent applications set out in Schedule 1.

Share Sale Agreement means the share sale agreement entered into between Vision Systems Limited and Oddy Bidco (Aus) Pty Ltd ACN 117 085 759 dated 27 January 2006.

Trade Marks means the trade mark registrations and trade mark applications set out in Schedule 2, including all unregistered or common law rights in those items, any goodwill associated with those items and any copyright subsisting in any logos in those items.

VFS Group means:

- (a) the Assignor;
- (b) the Assignee;

- (c) Vision Fire & Security Pty Limited;
- (d) Vision Systems Inc, a Maryland corporation;
- (e) Vision Systems (Europe) Ltd, incorporated in the United Kingdom with Co. No. 2387141;
- (f) VFS International Pty Ltd ACN 100 259 381;
- (g) VFS International Holdings Limited; and
- (h) VFS Holdings (Aust) Pty Ltd ACN 117 085 159.

1.2 Interpretation

In this deed, except where the context otherwise requires:

- (a) the singular includes the plural and *vice versa*, and a gender includes other genders;
- (b) another grammatical form of a defined word or expression has a corresponding meaning;
- (c) a reference to a clause, paragraph, schedule or annexure is to a clause or paragraph of, or schedule or annexure to, this deed, and a reference to this deed includes any schedule or annexure;
- (d) the meaning of general words is not limited by specific examples introduced by **including**, **for example** or similar expressions; and
- (e) a rule of construction does not apply to the disadvantage of a party because the party was responsible for the preparation of this deed or any part of it.

2. Assignment of IP

The Assignor, as the legal and beneficial owner of IP, assigns to the Assignee, and the Assignee accepts the assignment of, with effect from the Effective Date:

- (a) all of the IP; and
- (b) all of the Assignor's rights to take action against any third party in respect of any infringement or breach of the IP (whether the infringement occurred on or before the Effective Date).

3. Acknowledgements

The Assignor acknowledges and agrees that:

- (a) from the Effective Date, it has no right to the IP and must not exercise any rights in the IP except pursuant to a separate arrangement with the Assignor or the Assignor's licensee;
- (b) it will continue to hold as confidential any IP that is confidential at the Effective Date and will not disclose such IP to any person.

4. Further assurances

- (a) The Assignor agrees to execute all documents, forms and authorisations and to do any and all such acts and things as may be reasonably necessary in order to vest in the Assignee the rights assigned to the Assignee under clause 2 of this deed and any applications or registrations assigned or confirmed under clause 4(b), and, where necessary, execution of confirmation assignments where reasonably requested by the Assignee.

- (b) At any time after the date of this deed, if either party becomes aware of any IP that is registered or the subject of an application but that is not included in this deed, that party must notify the other and the Assignor will, at the Assignee's request, procure or confirm the assignment of that IP on the same terms as this deed.
- (c) The Assignee agrees to bear the costs in relation to the recordal including any requirements for recordal such as translation, legalisation and notarisation of the assignment of the IP and in relation to the assignment and recordal of any applications or registrations assigned or confirmed under clause 4(b).

5. Miscellaneous

5.1 Alterations

This deed may be altered only in writing signed by each party.

5.2 Costs

Each party must pay its own costs of negotiating, preparing and executing this deed.

5.3 Counterparts

This deed may be executed in counterparts. All executed counterparts constitute one document.

5.4 Assignability

The Assignor acknowledges and agrees that the Assignee and the companies within the VFS Group may assign their rights under this deed to, or grant security over their rights under this deed in favour of, any provider of financial accommodation to a company within the VFS Group, or to a security trustee for and on behalf of the providers of financial accommodation to a company within the VFS Group.

5.5 Tax

Any stamp duty, duties or other taxes of a similar nature (including fines, penalties and interest) in connection with this deed shall be paid by the Assignee.

5.6 Severability

A term or part of a term of this deed that is illegal or unenforceable may be severed from this deed and the remaining terms or parts of the term of this deed continue in force.

5.7 Waiver

A party does not waive a right, power or remedy if it fails to exercise or delays in exercising the right, power or remedy. A single or partial exercise of a right, power or remedy does not prevent another or further exercise of that or another right, power or remedy. A waiver of a right, power or remedy must be in writing and signed by the party giving the waiver.

5.8 Relationship

Except where this deed expressly states otherwise, it does not create a relationship of employment, trust, agency or partnership between the parties.

5.9 Entire agreement

This deed constitutes the entire agreement between the parties in connection with the subject matter of this deed.

5.10 Governing law and jurisdiction

This deed is governed by the laws of Victoria, Australia and each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of Victoria, Australia.

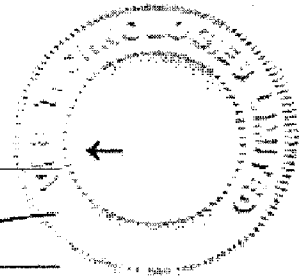


