**DECLARATION OF ANGELO NOTARO**

Angelo Notaro duly declares:

1. I am an attorney duly representing the registrant of the subject registration and make this declaration on behalf of the registrant, as its attorney, in order to correct a change of ownership incorrectly recorded by another person against the registration, pursuant to the provisions of TMEP § 503.06(c).

2. I filed a combined declaration of use and incontestability under sections 8 and 15 of the Trademark Act in connection with the subject registration for adidas-Salomon on February 18, 2005 via an application duly signed on behalf of the adidas-Salomon A.G.. which grants me, and other attorneys in the law firm of Notaro & Michalos P.C., a power of attorney to prosecute the application, to transact all business in connection therewith, and to receive the certificate of registration. The aforesaid power of attorney has not been revoked and has continuously been effective to and including the date of this declaration.

3. On about July 18, 2005, the undersigned became aware of the recordation of name change documents in connection with the subject registration.

4. Specifically, a notice of acceptance and acknowledgment of the Sections 8 and 15 declaration was received on July 18, 2005 which listed the owner of the subject registration as CNL Desert Resort, LP.

5. Investigation of this matter revealed that the recordation of a name change of KSL Desert Resorts, Inc. to CNL Desert Resort, LP at reel/frame 3059/0626 on March 8, 2005 against the subject registration.

6. The recordation was and is an error resulting from a mistake in a serial number in documents recorded by Mr. C. Douglas McDonald, P.O. box 3239, Tampa, FL

7. I wrote to Mr. McDonald at the foregoing address on July 27, 2005 and explained the error and requested that he correct it.

8. I did not receive a response to my letter of July 27, 2005 and again wrote to Mr. McDonald on September 7, 2005 requesting that he let me know if any action had been taken to correct the error in the recorded name change.

9. A review of the USPTO's assignment records on October 4, 2005 reveals that the error still had not been corrected.

10. The correct owner of the above-identified application is adidas-Salomon AG by virtue of an assignment from the original registrant adidas AG which was duly recorded at reel/frame 1707/0080 recorded on March 9, 1998

11. adidas-Salomon AG. has not changed its name.

12. adidas-Salomon AG has not authorized anyone to record a name change against registration no. 2,278,591.

13. adidas-Salomon AG continues to be the owner of the registration at issue.

14. The erroneous recordal of the name change of KSL Desert Resorts, Inc. to CNL Desert Resort, LP at reel/frame 3059/0626 on March 8, 2005 against the subject registration is a clear break in the chain of title and is an error.

15. It is respectfully requested that the Office correct its assignment records to show adidas-Salomon AG as the owner of the registration and that a new notice of acceptance and acknowledgment of the Sections 8 and 15 declaration be issued to and in the name of adidas AG.

The undersigned being duly hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements may jeopardize the validity of the application or any resulting registration, declares that he/she is properly authorized to execute this declaration on behalf of the applicant; he/she believes the applicant to be the owner of the trademark/service mark sought to be registered, or, if the application is being filed under 15 U.S.C. 1051(b), he/she believes applicant to be entitled to use such mark in commerce; to the best of his/her knowledge and belief no other person, firm, corporation, or association has the right to use the above identified mark in commerce, either in the identical form thereof or in such near resemblance thereto as to be likely, when used on or in connection with the goods/services of such other person, to cause confusion, or to cause mistake, or to deceive; and that all statements made of his/her own knowledge are true and all statements made on information and belief are believed to be true.
