## TRADEMARK ASSIGNMENT

This is an agreement by and between the below parties ("Agreement") with an effective date as of the last date this Agreement was signed ("Effective Date").

WHEREAS, Hewlett-Packard Development Company, L.P., a Texas limited partnership with its principal place of business at 20555 S.H. 249, Houston, Texas 77070 U.S.A. ("HPDC"), owns and is using the ARJUNA mark;

WHEREAS, HPDC owns the trademark registrations for the ARJUNA mark listed in Exhibit A for the goods and/or services described therein;

WHEREAS, Arjuna Technologies Ltd., is a United Kingdom corporation, with its registered office at Floor A, Milburn House, Dean Street, Newcastle upon Tyne, NE1 1LE, England ("Arjuna Technologies"); and

WHEREAS, the parties desire to transfer to Arjuna Technologies all of HPDC's trademark rights in and to the ARJUNA mark under the terms and conditions of this Agreement.

NOW, THEREFORE, in consideration of the mutual promises contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. **ASSIGNMENT.** HPDC hereby assigns to Arjuna Technologies all its rights, title and interest in and to the ARJUNA mark throughout the world including all goodwill associated therewith and all the related registrations, including those listed in Exhibit A to this Agreement, and the right to sue and collect damages for past infringements of such mark.
2. **DOCUMENTATION.** HPDC agrees to execute further such documents as may be reasonably necessary to transfer or record the transfer to Arjuna Technologies of the rights contemplated herein, provided that these documents do not materially change the terms of this Agreement.
3. **REPRESENTATION AND WARRANTIES.** HPDC HEREBY DISCLAIMS ALL REPRESENTATIONS AND WARRANTIES, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, WITH RESPECT TO THE ARJUNA MARK, INCLUDING ANY WARRANTY OF TITLE, NONINFRINGEMENT, MERCHANTABILITY, AND FITNESS FOR A PARTICULAR PURPOSE. HPDC ASSIGNS THE ARJUNA MARK AND ASSOCIATED REGISTRATIONS ON AN "AS-IS" BASIS. ARJUNA TECHNOLOGIES ACKNOWLEDGES THE ABOVE DISCLAIMERS MADE BY HPDC AND EXPRESSLY ACCEPTS AND ASSUMES ANY AND ALL LIABILITIES, DEBTS, AND OTHER OBLIGATIONS ASSOCIATED WITH THE ARJUNA MARK.

HPDC makes no representations and warranties as to the extent or the validity of its rights in the ARJUNA mark, or as to the status of any associated registrations and HPDC makes no other warranty or representation as to the rights or registrations assigned herein.

4. GOVERNING LAW. This Agreement shall be governed in its enforcement, construction and interpretation under the law of the State of Delaware and both parties agree to the venue for such disputes in the State of Delaware.
5. ENTIRE AGREEMENT. This Agreement constitutes the entire agreement between the Parties hereto with respect to the subject matter of this Agreement. This written document supersedes any prior agreements, understandings, communications, discussions, or negotiations concerning the subject matter hereof.



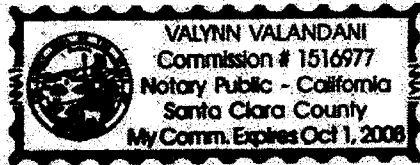
