- (2) The Assignor undertakes to execute all such documents, forms and authorisations and depose to or swear any declaration or oath as may be required for vesting absolutely the full rights, title and interest in the registrations and in the Trade Marks in favour of the Assignee.
- (3) The Assignment is governed by the laws of England.
