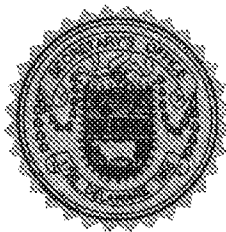

**CERTIFICATE OF CONVERSION  
TO LIMITED PARTNERSHIP**
