TRADEMARK ASSIGNMENT

Assignor acknowledges that Assignee has full right and authority to secure trademarks or service marks in all aspects of the Trademarks throughout the world and to have and hold such trademarks for the full term.

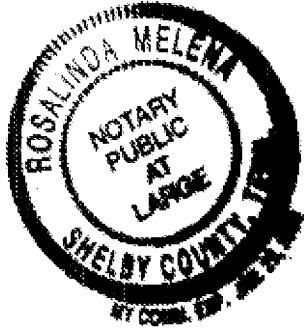
