TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

Reference is hereby made to that certain Trademark Security Agreement, dated as of March 12, 2004 (as amended and supplemented from time to time prior to the date hereof, the "**Trademark Security Agreement**"), executed by Menominee Acquisition Corporation, a Delaware corporation, Cellu Tissue Corporation - Neenah, a Delaware corporation, Interlake Acquisition Corporation Limited, a Nova Scotia corporation (each a "**Grantor**") in favor of The CIT Group/Business Credit, Inc. (the "**Administrative Agent**"), acting in its capacity as Administrative Agent for the Secured Parties (as such terms are defined in the Trademark Security Agreement), pursuant to which the Grantors assigned, granted, conveyed, pledged, hypothecated and transferred to Administrative Agent (on behalf of itself and the Secured Parties) a security interest in and to all of each Grantor's right, title and interest in and to its respective trademarks and trademark licenses, including without limitation those set forth on Schedule 1 attached hereto, and the goodwill associated with each of the foregoing and all continuations or extensions of the foregoing, and all products and proceeds of the foregoing, as more fully described in the Trademark Security Agreement (collectively, the "**Trademark Collateral**") ; and

WHEREAS, Administrative Agent wishes to release its security interest in the Trademark Collateral and retransfer and reassign to each Grantor, without representation or warranty, and without recourse, all of the Administrative Agent's right, title and interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby releases any security interest it may have in the Trademark Collateral and retransfers and reassigns to each Grantor, without representation or warranty, and without recourse, all of the Administrative Agent's right, title and interest in and to the Trademark Collateral.

IN WITNESS WHEREOF, Administrative Agent has executed this Termination and Release of Security Interest in Trademarks on behalf of itself and the Secured Parties as of this 8th day of June, 2006.

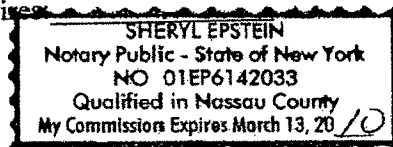
