NOW, THEREFORE, for good and valuable consideration, the full receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor hereby sells, assigns, transfers and conveys unto Assignee all of its right, title and interest in and to the aforesaid Trademarks and Copyrights, including any choses in action relating to said Trademarks and Copyrights, claims for damages, profits and costs, both in equity and law, for any infringement or infringements of said Trademarks and Copyrights accruing on or before the date of this Assignment, together with the goodwill of the business symbolized by the Trademarks, and including the registrations thereof as set forth above, nunc pro tunc effective **January 1, 2006**, and further, Assignor hereby covenants, agrees and undertakes to execute, whenever requested by Assignee, all applications, assignments, lawful oaths and any other papers which Assignee may deem necessary or desirable for securing to Assignee or for maintaining for Assignee the Trademarks and Copyrights hereby assigned, all without further compensation to Assignor.
