TRADEMARK ASSIGNMENT

This Trademark Assignment ("Trademark Assignment") is made effective as of this 15th day of June, 2006 from Marie Brizard et Roger, Inc., a New York corporation ("ASSIGNOR"), to Marie Brizard & Roger International, a French legal entity ("ASSIGNEE").

RECITALS

- A. Assignor owns the trademark registrations (the "Trademarks") described in Exhibit A hereto, together with the goodwill associated with the Trademarks.
- B. Assignee wishes to acquire Assignor's rights in the Trademarks, and Assignor wishes to sell such rights to Assignee on the terms and conditions set forth below.

ASSIGNMENT

1. In consideration of the payment by Assignee to Assignor of the Purchase Price (as defined below) and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers and sells to Assignee all of Assignor's right, title and interest to the Trademarks, whether statutory or at common law, together with the goodwill associated with the Trademarks, and all causes of action for any and all previously occurring infringements or misappropriations of the rights being assigned and the right to receive and retain the proceeds relating to those infringements or misappropriations.
2. The purchase price ("Purchase Price") for the Trademarks is Sixty Thousand U.S. Dollars (US\$ 60,000).
3. Assignor will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Trademarks.

This Trademark Assignment may be executed in several counterparts, each of which shall be deemed to be an original, but all of which together will constitute one and the same instrument.
