TRADEMARK ASSIGNMENT

WHEREAS, Joey Bed, Inc. (the "**Assignor**"), an Oregon corporation located at 2627 SE Holgate Blvd., Portland, OR 97207, has adopted and used and is the sole and exclusive owner of the trademark and related registration listed in the attached Schedule A (the "**Trademark**"), and of all of the goodwill of the business appurtenant thereto; and

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for and in consideration of the sum of One Dollar (\$1.00), and other valuable and legally sufficient consideration, the receipt and legal sufficiency of which is hereby acknowledged, the Assignor has sold, assigned and transferred, and by these presents does sell, assign and transfer unto the Assignee, the entire right, title and interest in and to the Trademark, and in and to all of the goodwill of the business appurtenant thereto, together with all claims for damages by reason of infringement of same, with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives.

The Assignor hereby warrants and covenants that it has not executed, and will not execute, any agreements inconsistent herewith.

The Assignor, for itself and its successors and assigns, hereby covenants and agrees to execute any instruments and to perform any acts which may be necessary to fully effectuate and record this Assignment, including at any time and from time to time forthwith upon the request of the Assignee, the Assignor will do, execute, acknowledge and deliver or cause to be done, executed, acknowledged and delivered, all such further acts, deeds, instruments, transfers and assurances as may be reasonably required by the Assignee in order to assign, transfer, set over and convey unto, and vest in, the Assignee, its respective successors and assigns, any or all of the Trademarks, and to put the Assignee in actual possession and operating control thereof, free and clear of all liens, to assist the Assignee in exercising all rights with respect thereto and to assure the Assignee of the full benefits thereof.

This Trademark Assignment shall be binding upon and shall inure to the benefit of the respective successors and assigns of the Assignor and the Assignee. This Trademark Assignment shall not confer any rights or remedies upon any person other than the parties hereto, and their respective successors and assigns.
