Assignor agrees to cooperate with Assignee in filing documents with the United States Patent & Trademark Office to obtain a recording of this Assignment in the United States Patent & Trademark Office. Assignor further agrees to cooperate with Assignee in executing, and assisting Assignee in recording, such further documents, including additional assignments, as may be required by the law of any foreign country to convey the foregoing rights to Assignee.

The terms and provisions of this Assignment shall be binding upon Assignor and its successors and assigns and will inure to the benefit of Assignee and its successors and assigns.

This Assignment may be executed in any number of counterparts each of which when so executed and delivered shall be considered an original, and such counterparts shall together constitute one and the same instrument. Any such counterpart which may be delivered by facsimile, email or similar electronic transmission shall be deemed the equivalent of an originally signed counterpart and shall be fully admissible in any proceedings regarding this Assignment.


