This Assignment is given pursuant to the Asset Agreement and is subject to the terms thereof and shall not be construed to limit, alter, impair, enhance or enlarge the rights and obligations of Grantee and Grantor under the Asset Agreement and is given solely for purposes of separately evidencing the transactions contemplated thereby.


