TRADEMARK ASSIGNMENT

WHEREAS, Hubbard is executing this Assignment pursuant to the Agreement dated June 26th, 2006 (the "Agreement") and the Agreement governs and controls this Assignment in all respects; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby transfers and assigns to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignor's right, title and interest in and to the Subject Mark together with the registration thereof and all goodwill of the business symbolized thereby or connected therewith, effective as of the Effective Date. This transfer and assignment includes the right to recover for any third party infringement thereof, regardless of whether such infringement occurred before or occurs after the Effective Date. This transfer to Assignee includes, without limitation, all common law rights, interests and goodwill as may have been acquired by Assignor from the use of said Subject Mark.
