TRADEMARK ASSIGNMENT



NOW, THEREFORE, for and in consideration of the mutual covenants and agreements contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign, transfer and deliver to Assignee, its successors, assigns and legal representatives, its full and exclusive right, title and interest in and to the Trademarks, together with the goodwill of the businesses symbolized by the Trademarks and associated therewith, or to which the Trademarks pertain, and all other common law rights and applications and registrations of the Trademarks, and the right to recover for damages and profits for past infringements of the Trademarks.

This assignment shall be binding upon Assignor's successors, assigns and legal representatives, and shall inure to the benefit of Assignee, its successors, assigns and legal representative, as the case may be.
