Pursuant to Article 3.06 of the Texas Limited Liability Company Act, the undersigned limited liability company hereby files the following Articles of Amendment:

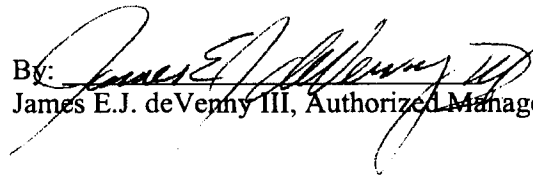
1. The name of the limited liability company is: Collocation Solutions, L.L.C.
