

ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION  
OF  
POCAHONTAS FOODS, USA, INC.

In accordance with the provisions of Section 13.1-710 of the Virginia Stock Corporation Act, Pocahontas Foods, USA, Inc. (the "Corporation") hereby adopts the following Articles of Amendment (the "Articles of Amendment") to its Articles of Incorporation (the "Articles of Incorporation"):

1. Name of Corporation. The name of the Corporation is Pocahontas Foods, USA, Inc.

2. Article 1 of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

Article 1: The name of the Corporation is Progressive Group Alliance, Inc.

4. Except as amended by these Articles of Amendment, the Articles of Incorporation of the Corporation shall remain in full force and effect.

5. Adoption. These Articles of Amendment were duly adopted and submitted to the sole shareholder for approval by the Board of Directors on November 16, 2004.

6. Unanimous Consent. These Articles of Amendment were adopted unanimously by the sole shareholder of the Corporation on November 16, 2004.

6. Effective Date. These Articles of Amendment will be effective when filed with the Secretary of State.
