AFFIDAVIT OF JOHN C. WHEELER

I, JOHN C. WHEELER, declare as follows:

1. I am over the age of 18 years and am an agent and representative of William A. Brandt, Jr., not individually, but solely as Assignee (the "Assignee") for the Benefit of Creditors of Processed Plastic Company.

2. On or about July 14, 2005, on behalf of the Assignee, the Assignee's counsel and I conducted an auction (the "Auction") for the sale of certain assets of Processed Plastic Company. At the Auction, the Assignee auctioned off Processed Plastic Company's right title and interest, if any, in various trademark rights. However, the trademark rights associated with DOUBLE ACTION ENDLESS BUBBLES and ENDLESS BUBBLES were specifically excluded from the Auction.

3. J. Lloyd International, Inc. ("J. Lloyd") purchased many of the assets of Processed Plastic Company at the auction; however, they did not purchase the trademark rights associated with the ENDLESS BUBBLES and DOUBLE ACTION ENDLESS BUBBLES trademarks because those trademarks were specifically excluded from the Auction.

4. On or about October 10, 2005, I received an Assignment document (the "Assignment") prepared by J. Lloyd, which purportedly identified in an attached schedule the trademark applications and registrations that J. Lloyd had purchased at the Auction. Although I signed the Assignment, I inadvertently overlooked the fact that it included U.S. Trademark Registration No. 2,488,861 for ENDLESS BUBBLES, and Trademark Registration No. 2,859,632 for DOUBLE ACTION ENDLESS BUBBLES. The inclusion of these trademarks in the Assignment was inadvertently overlooked by me and should not have been included in the schedule of trademarks.

5. It has since come to my attention that J. Lloyd subsequently recorded the above-referenced Assignment with the Assignment Division of the United States Patent and Trademark Office. It appears that J. Lloyd also included U.S. Trademark Registration Nos. 2,488,861 for ENDLESS BUBBLES and 2,859,632 for DOUBLE

ACTION ENDLESS BUBBLES on the "Trademark Assignment" that it submitted to the United States Patent and Trademark Office on or about November 30, 2005.

6. As an agent of William A. Brandt, Jr., not individually, but solely as Assignee for the Benefit of Creditors of Processed Plastic Company, I hereby rescind the Assignment I executed on October 10, 2005 to the extent it purports to transfer the ENDLESS BUBBLES and DOUBLE ACTION ENDLESS BUBBLES trademarks to J. Lloyd.

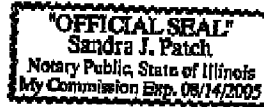
