**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE effective as of June ~~26~~, 2006, from Credit Suisse (formerly known as Credit Suisse First Boston), as Administrative Agent (the "Agent") for certain banks and other financial institutions (the "Lenders"), to CB Richard Ellis, Inc., a Delaware corporation with its principal place of business located at 100 North Sepulveda Blvd., Suite 1050, El Segundo, CA 90245 (formerly 533 S. Fremont Avenue, Los Angeles, CA 90071).

WITNESSETH:

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of July 20, 2001, made by the Grantors (as defined therein), including CB Richard Ellis, Inc., in favor of the Agent (the "Guarantee and Collateral Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Guarantee and Collateral Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on December 11, 2001, at Reel 2406 and Frame 0146; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks, including those listed on Schedule A hereto. The term "Trademarks" shall have the meaning provided by reference in the Guarantee and Collateral Agreement and the Trademark Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
