CONFIRMATORY ASSIGNMENT OF TRADEMARKS

WHEREAS, as of June 13, 1997, Vibe Ventures (hereinafter referred to as "Assignor"), a general partnership organized under the laws of the State of California with an address at 215 Lexington Avenue, New York, New York 10016, United States of America, has adopted and used in its business the trademark VIBE, Registration No. 1800105 (the "Trademark");

WHEREAS, pursuant to a contribution agreement made of June 13, 1997 ("Contribution Agreement"), all of the partnership interests of Assignor, were conveyed to Vibe Ventures LLC (hereinafter referred to as "Assignee"), a limited liability company organized under the laws of the State of Delaware with an address at 11100 Santa Monica Boulevard, Suite 1910, Los Angeles, California 90025, United States of America;

WHEREAS, pursuant to Section 16302(d) of the California Uniform Partnership Act of 1994 (the "Act"), by virtue of the fact that Assignee became the owner of all the partnership interests of Assignor, all right, title and interest in all partnership property of Assignor, including, but not limited to all rights in the Trademark, vested in Assignee;

WHEREAS, pursuant to Section 16302(d) of the Act, Assignee, as the successor owner of all partnership property of Assignor, including all rights in the Trademark, may execute a document in the name of the Assignor to evidence vesting of the partnership property in the Assignee and file or record such document;

NOW THEREFORE, for avoidance of any doubt, Assignor hereby confirms that it has assigned, sold, and transferred to Assignee, its successors and assigns, all right, title and interest in and to the Trademark, together with the goodwill of the business symbolized by and associated with such Trademark, as of June 13, 1997.
