This Assignment of Trademark Rights shall be effective as of August 14, 2001.



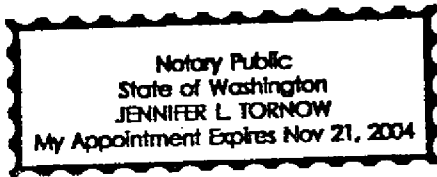
MSR hereby authorizes and requests any concerned agency, office, or entity to record Cascade as the assignee of MSR's entire right, title, and interest in such trademark rights.
