ASSET TRANSFER AGREEMENT AND TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Assignment") is made effective as of June 21, 2006 by and between TRADEMARK HOLDINGS, LLC, a limited liability company organized and existing under the laws of the State of Missouri, having its principal office and place of business at 1000 Walnut Street, Suite 1400, Kansas City, Missouri 64106 (herein, "Assignor") and GREATWIDE LOGISTICS SERVICES, INC. f/k/a Transport Industries Holdings, Inc., a company organized and existing under the laws of the State of Delaware, having its principal office and place of business at 5215 N. WHEREAS, Assignor has intended to use the trademarks listed on Schedule A (herein, "the Marks") in commerce and has filed trademark applications indicating that intention, but has not yet filed an allegation of use under §§1(c) or 1(d) of the Trademark Act, and;

WHEREAS, Assignor is assigning the Marks as part of the entire business or portion thereof to which the marks pertain as required by 15 U.S.C. §1060;

WHEREAS, Assignee, the successor of the ongoing and existing business of Assignor to which the Marks pertain, is desirous of acquiring said trademarks and the pending intent-to-use applications therefor; and

WHEREAS, Assignee is the sole member of and is the controlling entity of Assignor.

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby assign and transfer to Assignee all right, title, and interest in and to the entire business and all assets of Assignor including the Marks and the goodwill of the business symbolized thereby as follows:

1. Assignor does sell, assign, and transfer all its right, title, and interest, anywhere in the world, in and to the entire business and all assets of Assignor including the Marks unto Assignee, the applications and subsequent registrations therefor, together with the goodwill of the business in connection with which the Marks are used and that part of the goodwill of the business connected with the use of and symbolized by the Marks.
2. Assignor further agrees to execute and deliver such other or further documents or instruments as may be necessary, in the judgment of Assignee's counsel, to perfect Assignee's rights in and to the Marks.
3. This Assignment includes any and all rights to recover all damages for infringement of the Marks, whether such infringement occurred in the past or occurs in the future, as fully as if Assignor had filed such action in its own name. Further,

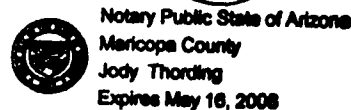
