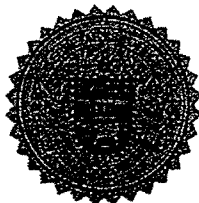

FIRST: The name and jurisdiction of organization of each of the constituent entities to the merger is as follows:
