AFFIDAVIT OF LUIS SANTAMARIA MORALES

The undersigned, Luis Santamaria Morales, Director of Bodegas y Bebidas, S.A., a Spanish corporation, being warned that wilful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such wilful false statements and the like may jeopardize the validity of the trademark registrations referred to herein, declares that all statements made of his own knowledge are true; and all statements made on information and belief are believed to be true; declares as follows:

1. The company "Azpilicueta, Garcia-Lafuente y Entrena, Bodegas Unidas, S.A." changed its name to Bodegas Age, S.A. on 27 of April 1990. On April 1 2004, this company merged into Bodegas Domecq, S.A. (which on 29 of March 2004 ^{and simultaneously} changed its name to Bodegas y Bebidas, S.A.
2. The company "Azpilicueta, Garcia-Lafuente y Entrena, Bodegas Unidas, S.A.", was sometimes used in the following shortened versions: AGE, Bodegas Unidas, S.A., or A.G.E. Bodegas Unidas, S.A.
3. The shortened name AGE, Bodegas Unidas, S.A. was wrongly indicated as the proprietor of Trademark Registration Nos. 1007676 and 1026930. Similarly, the shortened name A.G.E. Bodegas Unidas, S.A. was wrongly indicated as the proprietor of Trademark Registration Nos. 1052562 and 1054440.
4. The correct owner of all four Trademark Registrations listed in paragraph 3 above, should have been indicated as: "Azpilicueta, Garcia-Lafuente y Entrena, Bodegas Unidas, S.A".

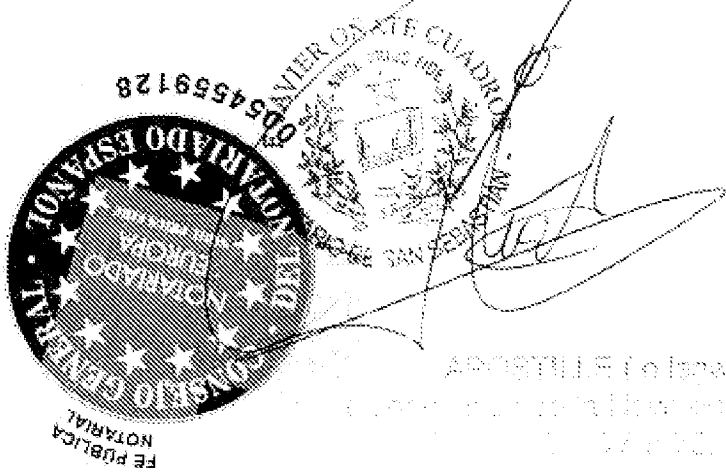

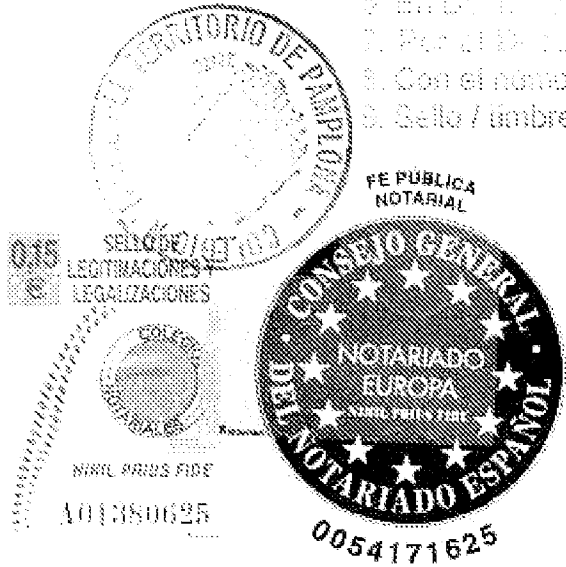
