This TRADEMARK ASSIGNMENT (this "*Assignment*") is made and entered into as of April 19, 2006 by and between Lucasfilm Entertainment Company Ltd., with an address at P.O. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, LECL hereby assigns, grants, transfers and conveys to Pandemic all of Lucas' right, title and interest of every kind and nature throughout the territory and jurisdiction of the United States to the MERCENARIES trademark, including the trademark application identified as follows:
