1. Patriot Funding Limited Partnership, a Massachusetts limited partnership, filed Application Serial No. 75/032,672 to register the mark subject to Registration No. 206466 (hereinafter, the "Registration") on December 14, 1995, and the Registration correctly issued in the name of Patriot Funding Limited Partnership on May 27, 1997;
2. Patriot Funding Limited Partnership converted to a limited liability company under the laws of the Commonwealth of Massachusetts on October 20, 2003, and is now known as Patriot Funding, LLC.;
3. Patriot Funding, LLC, by and through its predecessor in interest Patriot Funding Limited Partnership, has been at all times and continues to be the true and correct owner of the Registration and the mark subject thereto;
4. On July 26, 2001, a nunc pro tunc assignment made by and between Hill-Rom, Inc. and Hill-Rom Services, Inc. (hereinafter, the "Assignment") was recorded in error against the Registration;
5. The Assignment was recorded at Reel 2338/Frame No. 00001;
6. The Assignment recorded at Reel 2338/Frame No. 00001 does not assign, or purport to assign, the Registration or the mark subject thereto;
7. The Assignment was recorded in error against the Registration as the result of an error in the associated Document Cover Sheet, which incorrectly included the Application Serial Number relevant to the Registration (Application Serial No. 75/032,672);

8. The chain of title to the Registration and the mark subject thereto should not be considered altered by the incorrect recordation of the Assignment against the Registration;
9. All attempts to contact the attorney who recorded the Assignment against the Registration in error have been unsuccessful.
