**ASSIGNMENT OF

BE IT KNOWN, that for and in consideration of the sum of money to the Seller in hand paid or to be paid by the Buyer, and other good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the Seller by these presents has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over to the Buyer, all of the Seller's rights, titles and interests in and to the Trademarks in the United States, its territorial possessions and all foreign countries throughout the world, together with the goodwill symbolized by the Trademarks, and including, without limitation, any registrations and applications therefore, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Trademarks, with the right to sue for, and collect thereupon.

The Seller hereby authorizes and requests the Commissioner of Patents and Trademarks to record Buyer as the assignee and owner of the Trademarks, and to issue any and all communications or correspondence pertaining to the Trademarks to the Buyer, as assignee of the entire interest.

The Seller agrees that upon request by the Buyer, or its successors, assigns or other legal representatives that the Seller or its successors, assigns or other legal representatives shall do all other legal acts reasonably necessary to carry out the intent of, and to record, this assignment at the Buyer's expense and reasonable request, as well as provide such other material, information, or assistance as Buyer or its successors, assigns or other legal representatives may consider necessary.
