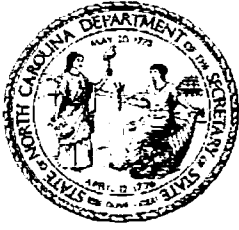

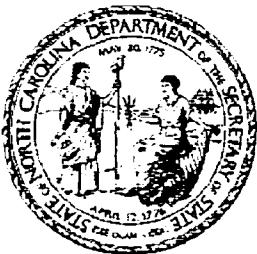

ARTICLES OF AMENDMENT

OF

CERTIFICATE OF INCORPORATION FOR ZELLWEGER USTER, INC.

Pursuant to §55-10-06 of the General Statutes of North Carolina, the undersigned corporation hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation.

- 1. The name of the corporation is: Zellweger Uster, Inc.
- 2. The text of each amendment adopted is as follows (State below or attach):

RESOLVED, that the Articles of Incorporation of Zellweger Uster, Inc., originally filed with the Secretary of State of the State of North Carolina on March 17, 1989, under the name of "Zellweger Uster Technologies, Inc.," as amended by the Articles of Merger of Zellweger Uster, Inc. into Zellweger Uster Technologies, Inc., filed with the Secretary of State of the State of North Carolina on April 18, 1991, be and the same is hereby amended by deleting Paragraph "1" in its entirety and substituting in lieu thereof the following:

"1. The name of the corporation is Uster Technologies, Inc."
