NOW, THEREFORE in consideration of and in exchange for the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign and transfer unto Assignee the entire right, title and interest in and to the Trademark Registrations and Applications, as well as any common law rights Assignor may have in the Mark, together with the goodwill of the business symbolized by said registrations, applications and mark, and the right to recover damages and profits for past infringement.

Assignor represents and warrants that (a) it is currently the owner of record of the Trademark Registrations and Applications; (b) other than the actions brought by or on behalf of Assignee, there are no claims or notices or threats of litigation, arbitration, or other contest adverse to the Trademark Registrations and Applications or the Mark; (c) neither it, nor anyone

acting under its direction, has sold or licensed any rights in the Trademark Registrations and Applications or the Mark to any third party; and (d) all necessary corporate and other actions have been taken for the execution, delivery, and performance of this assignment.

Assignor agrees to execute, and deliver at the request of Assignee, all papers, instruments and assignments, and to perform any other reasonable acts Assignee may require in order to vest all Assignor's rights, title and interest in and to the Trademark Registrations and Applications and the Mark in Assignee and to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.
