ASSIGNMENT OF TRADEMARK REGISTRATION

WHEREAS, The Listworks Corporation, Inc., a New York Corporation, adopted and used the mark LISTWORKS (the "Trademark"), which is registered in the United States Patent and Trademark Office, Registration No. 2,819,398, issued March 2, 2004.

WHEREAS, on February 18, 2005, Eric C. Kurtzman (now deceased) was appointed Trustee in Bankruptcy for The Listworks Corporation, Inc., and succeeded to all right, title and interest to the assets thereof.

WHEREAS, on December 7, 2005, Mark S. Tulis was appointed Successor Trustee in Bankruptcy for The Listworks Corporation, Inc. (Trustee), and succeeded to all right, title and interest to the assets thereof.

WHEREAS, Marketing Investors Corporation, ("Assignee"), a Delaware corporation, having a principal place of business at 1555 Regal Row, Dallas, Texas 75247, and who, together with its successors and assigns, is desirous of acquiring all right, title and interest in the aforementioned Trademark and Trademark registration and the goodwill associated therewith.

WHEREAS, Trustee has neither abandoned nor intended to abandon the Trademark.

NOW, THEREFORE, for good and valuable consideration furnished by the Assignee to the Trustee, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Trustee, hereby without reservation, assigns, transfers and conveys to the Assignee the entire right, title and interest in and to the Trademark, together with the goodwill of the business symbolized by the mark and the United States Trademark Registration No. 2,819,398.
2. Trustee, hereby without reservation, represents that it has neither abandoned nor intended to abandon the Trademark.
3. Trustee, hereby without reservation, authorizes Assignee to record this Assignment in the United States Patent and Trademark Office in its name or otherwise as it may deem advisable.
4. Trustee, hereby without reservation, authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to issue or transfer said Trademark to Assignee as assignee of the entire right, title and interest therein or otherwise as Assignee may direct.
5. Assignee hereby grants the Trustee a license to use the Trademark and trade name, LISTWORKS, and referenced in the first paragraph above, for use by the Trustee in connection with the liquidation of The Listworks Corporation, Inc. and for no

other purpose. Said license shall not be transferable and shall terminate upon the final liquidation of The Listworks Corporation, Inc.

6. Trustee will provide such assistance as is necessary and appropriate for Assignee to retain rights in Registration No. 2,819,398.

7. This Assignment may be signed in multiple counterparts and each copy shall be considered an original for all purposes. A telecopy or facsimile transmission of a signed counterpart of this Assignment shall be sufficient to bind the party or parties whose signature(s) appear(s) thereon.
