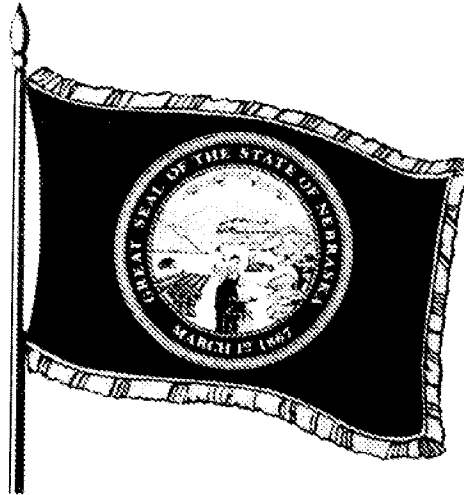

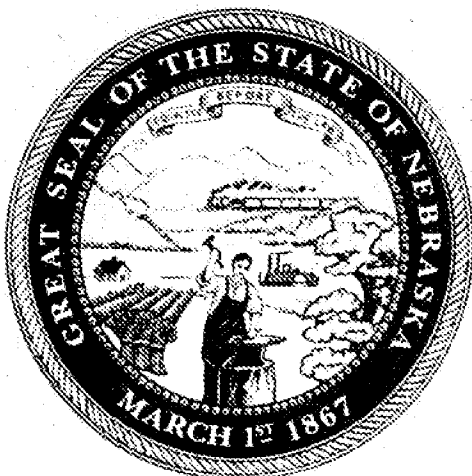

ARTICLES OF RESTATEMENT OF ARTICLES OF INCORPORATION

I
AMENDMENT

The Articles of Incorporation of NICHECOMMERCE, INC., a Nebraska Corporation (the "Corporation"), are amended by revoking Article I and adopting the following in substitution thereof:

"ARTICLE I
NAME


The name of the Corporation is NetShops, Inc. (the "Corporation")."
