"1.

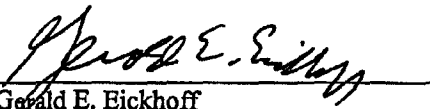
The name of the corporation is Enterpulse, Inc. (hereinafter referred to as the "Corporation")."
