**RELEASE OF GRANT OF SECURITY INTEREST
IN CERTAIN INTELLECTUAL PROPERTY**

This Release of Grant of Security Interest in Certain Intellectual Property (this "Release") is made and entered into this 17th day of ^{May}~~April~~, 2004 by and between Robertshaw Controls Company, a Delaware corporation (the "Borrower") and Deutsche Bank Trust Company Americas, a [New York] corporation, formerly known as, Bankers Trust Company (the "Lender").



WITNESSETH:

WHEREAS, the Lender has recorded a security interest in Borrower's trademarks set forth in Schedule A hereto (the "Intellectual Property") pursuant to that certain Security Agreement dated July 27, 1990 between Siebe, Inc, and Lender, as Agent (the "Security Agreement");

WHEREAS, such security interests were recorded in the Trademark Division of the United States Patent and Trademark Office, on October 10, 1990, at Reel 0745, Frame 0147;

WHEREAS, the pledged stock under the Security Agreement was returned to Siebe Inc., as evidenced in a letter dated January 18, 1996 from White & Case to Siebe Inc.; and

WHEREAS, the Borrower wishes to record the release of the security interests of the Lender granted under the Security Agreement in connection with the Intellectual Property, and the Lender has agreed to execute such release documentation.


NOW THEREFORE, in consideration of the foregoing, the parties to this Release intending to be legally bound, agree as follows.

1. The Lender hereby releases in its entirety any and all security interests it has in the Intellectual Property pursuant to the Security Agreement, and the Lender hereby agrees, at the expense of the Borrower, to take any actions and to execute any further documents necessary or reasonably requested by the Borrower to effectuate or evidence such release, including, but not limited to, the execution and delivery of those documents necessary under Article 9 of the Uniform Commercial Code or other applicable law.
2. The parties hereto authorize and request the Commissioner of Patents and Trademarks of the United States to record this Release.
3. This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to the conflict of law principles thereof.
4. This Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the parties hereto or their respective successors and assigns.
5. All rights hereunder shall accrue to, and all obligations hereunder shall be binding upon, the heirs, representatives, successors, assigns and transferees of the parties hereto.

6. This Release may be executed in any number of separate counterparts, each of which, when so executed, shall be deemed an original, and all of said counterparts taken together shall be deemed to constitute but one and the same instrument.


