Trademark Assignment

WHEREAS Proventiv Therapeutics, LLC, a Wisconsin limited liability company that was dissolved on January 9, 2006 by written agreement of all members ("Assignor"), owns an application for federal registration of the PROVENTIV THERAPEUTICS & DESIGN trademark (the "Mark") on the Principal Register of the United States Patent and Trademark Office in connection with the goods and/or services identified thereon, Serial Number 78768947 filed December 7, 2005 (the "Application"); and

WHEREAS Proventiv Therapeutics, LLC, a Delaware limited liability company whose address is 8550 Bakken Road, Mt. Horeb, Wisconsin ("Assignee"), desires to acquire the Mark and Application; and

WHEREAS Assignee has succeeded to the business of Assignor, as required by 15 U.S.C. § 1060(a);


NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign, transfer and convey unto Assignee the entire right, title and interest throughout the world in and to the Mark and the Application, and any registrations and applications relating to any of the foregoing, together with the goodwill of the business symbolized by the Mark, and all rights, claims and privileges pertaining to any of the foregoing, including, without limitation, the right to sue and recover damages for past, present and future infringement thereof, and the right to prosecute and maintain trademark applications and the registrations for the Mark and the Application, effective as of the 30th day of January, 2006.

Assignor shall take all actions reasonably requested by Assignee (at Assignee's expense), and shall execute any documents as may be reasonably requested by Assignee, from time to time to fully vest or perfect in Assignee all right, title and interest in and to the Mark and the Application. Such actions shall include, without limitation, providing documents and information useful or necessary for Assignee or its affiliates, designees or agents to prosecute or maintain any registration or application for the Mark and/or the Application, or pursue or defend any administrative, court, or other legal proceeding involving the Mark and/or the Application.

This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. This Assignment shall be governed by and construed in accordance with the laws of the State of Wisconsin, excluding the conflicts-of-law provisions thereof.
