## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "Release") is made effective as of December 23, 2005 ("Effective Date") by and between Relco Corp., an Iowa corporation ("Relco"), Inter-Global Automotive Corp., a Texas corporation ("Inter-Global"), Combined Enterprises, Inc. a Kansas corporation ("Combined"), Add-On Distributing, Inc. a Delaware corporation ("Add-On"), AWMi Corp., a Texas corporation ("AWMi"), and Autovillage.com, Inc. a Minnesota corporation ("Autovillage.com") (collectively, with Relco, Inter-Global, Combined, Add-On, and AWMi the "Grantor"), and Wells Fargo Bank, National Association, acting through its Wells Fargo Business Credit operating division (successor to Wells Fargo Business Credit, Inc., a Minnesota corporation) ("Grantee").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and Grantee dated October 21, 2004 (the "Trademark Security Agreement"), Grantor irrevocably pledged and assigned to, and granted to Grantee a security interest, with power of sale to the extent permitted by law, in the Trademarks (as defined in the Trademark Security Agreement), including, without limitation, the United States trademark registrations and applications for registration set forth on Schedule A attached hereto, to secure payment of the Obligations (as defined in the Trademark Security Agreement).

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on January 14, 2005, at Reel 3014, Frames 0860-0872;

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases any and all security interests it has against the Trademarks (as defined in the Trademark Security Agreement), including without limitation, those certain Trademarks listed on Schedule A attached hereto.

Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.
