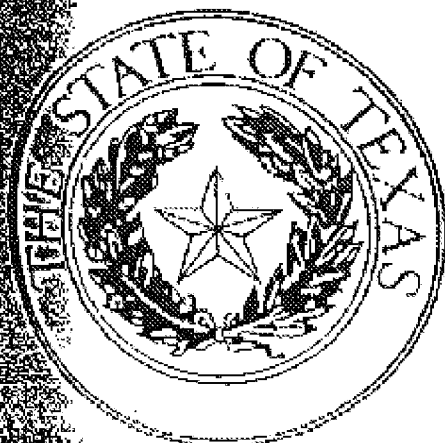

Pursuant to the provisions of the Texas Limited Liability Company Act, Tobin Data Graphics, LLC, a Texas limited liability company (the "Company"), adopts the following Articles of Conversion for the purpose of converting the Company into a Texas limited partnership:

1. The name of the converting entity is "Tobin Data Graphics, LLC", a Texas limited liability company.
2. A Plan of Conversion has been approved. Under the Plan of Conversion, the converted entity will be a limited partnership which will be formed under the laws of the State of Texas under the name Tobin International, Ltd.
3.
