

Pursuant to Section 61 of Chapter 156C of the Massachusetts General Laws

Pursuant to Section 61 of Chapter 156C of the Massachusetts General Laws, LightWedge, LLC, a Massachusetts limited liability company ("MA-LLC"), hereby states as follows with respect to the merger of LightWedge, LLC, a North Carolina limited liability company ("NC-LLC") with and into MA-LLC, with MA-LLC continuing as the surviving limited liability company (the "Merger"):

First: The name and state or jurisdiction of formation or organization of each of the limited liability companies which is to merge are as follows:

Third: The name of the surviving limited liability company is **LIGHTWEDGE, LLC**.

Fourth: The merger shall be effective upon the later to occur of (i) the filing of this Certificate of Merger with the Secretary of State of The Commonwealth of Massachusetts and (ii) the filing of Articles of Merger with the Secretary of State of the State of North Carolina.

Fifth: The executed Merger Agreement is on file at the place of business of MA-LLC located at Zero Washington Street, Nantucket, Massachusetts 02554.

Sixth: A copy of the Merger Agreement will be furnished by MA-LLC, on request and without cost, to any member of MA-LLC or NC-LLC.
